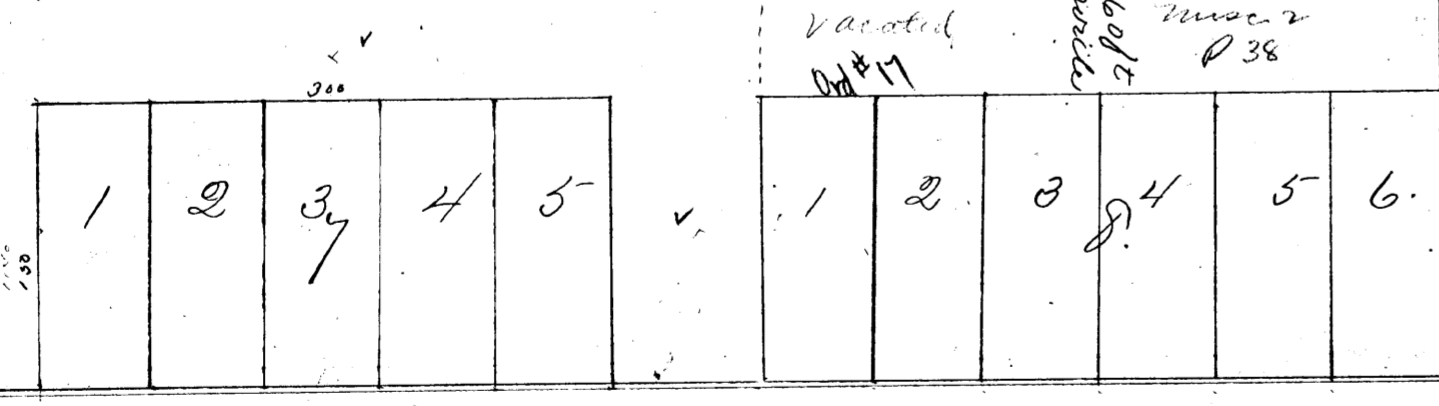
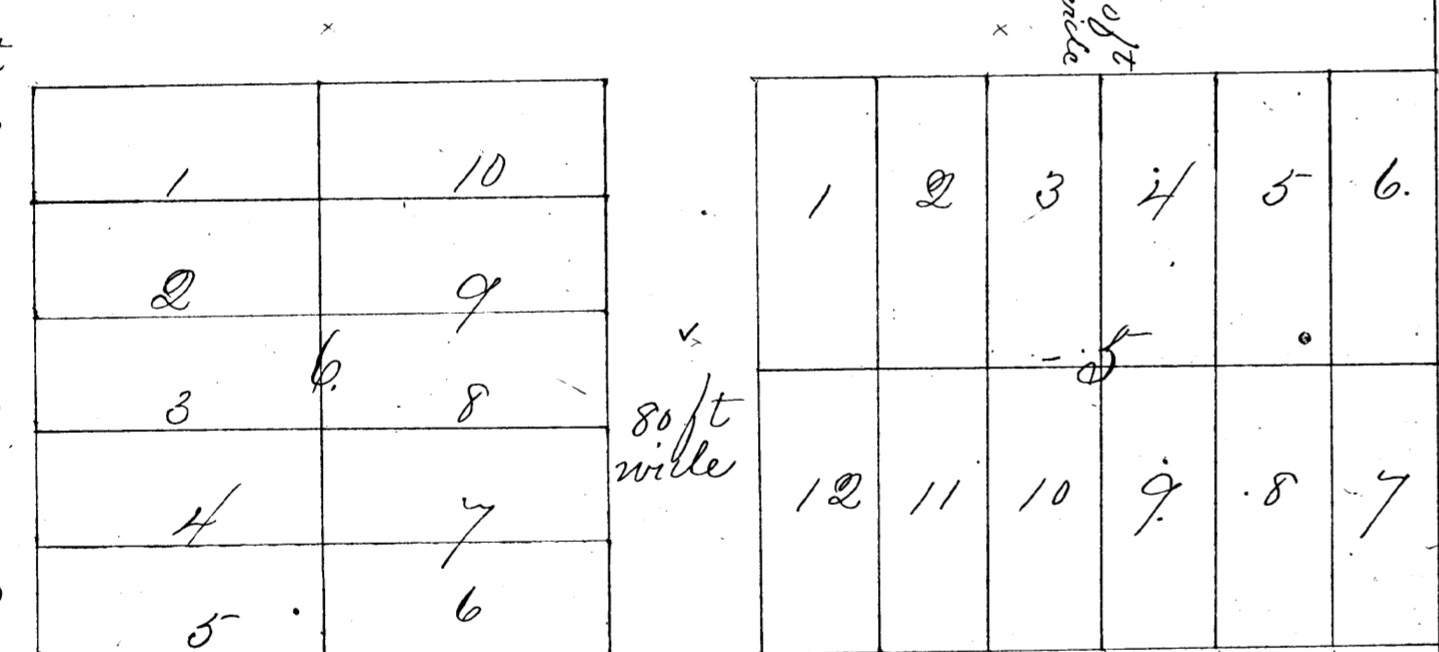
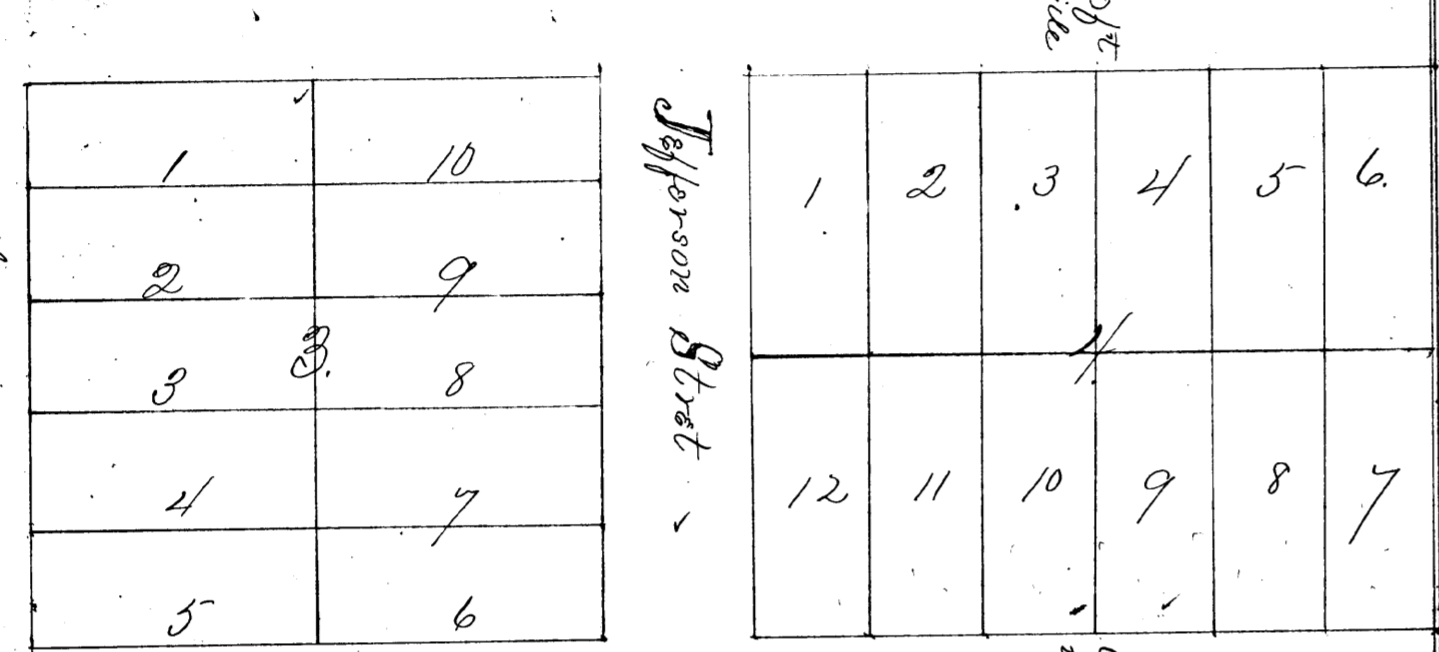
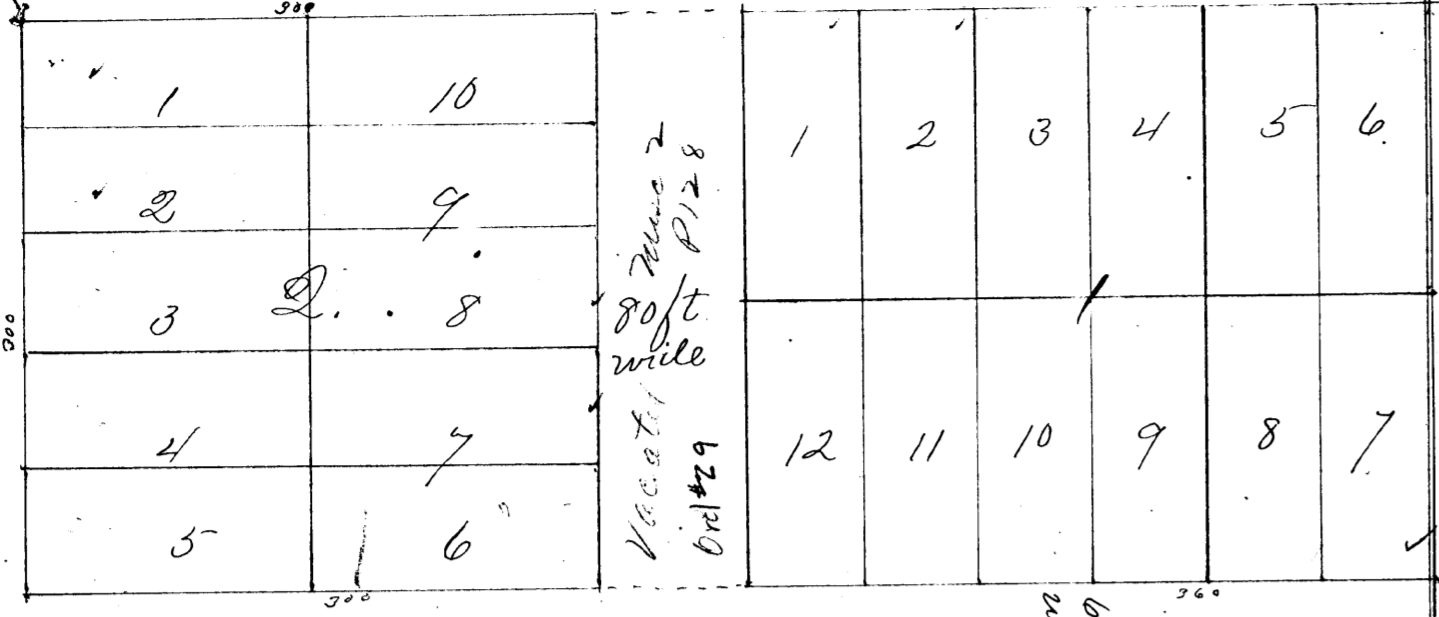


Plat of A Shultz Laclede Homestead Addition to the Town of Dallas Polk County Oregon
